175. MINUTES OF THE MEETING HELD MONDAY 7TH JANUARY 2019

176. LOCAL POLICING TEAM UPDATE

PCSO Darren Stretton provided an update report on crime and Police activity in Burbage. The Beat newsletter and speed data information had also been circulated to all Members prior to the meeting. Further clarification was given on the purpose and benefits of using Moveable Vehicle Activated Signs (MVAS) in the village.

177. CORRESPONDENCE

177.1 Resident email of concern regarding crime and security issues

An email had been received from a resident outlining crime and security concerns in their area and included a request for the Parish Council to consider how they could help. Following some discussion and input from PCSO Stretton, proposed by Cllr Mr Johnson, seconded by Cllr Mr Williams it was,

179. <u>MEADOWS COMMUNITY GROUP FUNDING REQUEST</u>

A request had been received from The Meadows Community Group who were seeking a contribution towards the cost of providing the Meadows Summer Play Scheme and for the free use of the Millennium Hall to hold dance and drama sessions. The play scheme is provided for Burbage children aged 6-12, free at the point of use. Proposed by Cllr Mr Lynch, seconded by Cllr Mr Johnson it was

RESOLVED – Due to development works the Millennium Hall would be unavailable to use during the summer holiday period, therefore an enhanced grant of £600 be awarded this year towards the cost of providing the summer play scheme.

180. <u>USE OF THE SCOUT BUILDING FOR AN ARTS AND CRAFTS DAY EVENT</u>

A request had been received from Burbage Community Arts Festival (BCAF) to obtain the Parish Council's formal permission to use the Scout building to hold an arts and crafts day event. Proposed by Cllr Mr Hall, seconded by Cllr Mrs Sherwin it was

<u>RESOLVED</u> – to give formal permission to BCAF to use the Scout Building and to confirm necessary liability insurance is in place.

181. <u>BURBAGE CONSTITUTIONAL BOWLING CLUB APPLICATION TO THE PARISH & COMMUNITY</u> INITIATIVE FUND

Burbage Constitutional Bowling Club are to submit an application to HBBC's Parish & Community Initiative Fund and were seeking the support of the Parish Council. Proposed by Cllr Mr Williams, seconded by Cllr Mrs Sherwin it was

<u>RESOLVED</u> – to support the grant application for a new lawnmower for the Burbage Constitutional Bowling Club.
